



Applying for a Business License

Any person carrying a business within the Town of Vermilion requires a valid Town of Vermilion Business Licence, unless specifically exempted by Provincial or Federal law. To apply for a Town of Vermilion Business License you must submit the 2020 Business Application and applicable fee. Please note, in some cases more information may be required depending upon the nature of the application. If this is the case, the Licence Coordinator will contact the applicant directly.
